Type of ledger: Business cashbook, record of customers and items sold.

Date: May 31st 1902- July 17th 1903

Items listed as sold within ledger:

- Food items such as coffee, sugar, starch, vinegar, lard, bacon, chip beef, candy, tobacco, flour, eggs, loafs of bread, wheat, apples, chocolate, soda, raisins, salt, oranges
- Supplies and hardware such as cotton cloth, oil, needles, horse shoes, paper, crayons, churn, shells, staples.
- Clothing items such as shoes, socks, shirts, stockings, spools of silk, hats.
