### A Community Begins Fact Sheet<sup>1</sup>

- The town, now called Scottsville, was founded on the *James River* because the rich farmland along the river was excellent for growing agricultural products and also transporting them to market.
- *Edward Scott* bought 550 acres of land along the James River's Horseshoe Bend in 1732, and a town called *Scott's Landing* soon grew up there.
  - This location near *Horseshoe Bend* had rich soil for farming and was along a major trading route, the James River.
- Edward Scott was the Burgess, Magistrate and Sheriff of Goochland County near Richmond.
- *Albemarle County* was formed in 1744 and *Scott's Landing* was its first *county seat*, which meant that it was the social, legal, and economic center of the county.
  - Scott's Landing served as county seat from 1744-1762.
  - Charlottesville became the county seat in 1762 and continues to serve that purpose today.
- Edward Scott died in 1738. In 1745, several important men met at his house, called Valmont, to organize Albemarle County.
  - Some of their tasks included: setting the prices of goods, collecting taxes, organizing a militia, building roads, establishing places for travelers to eat, drink, and spend the night, deciding where to build the courthouse, jail, and other important buildings and then building them.
- *Scott's Ferry* was built in 1745 by Edward Scott's son, Daniel. It connected the *courthouse* in Scott's Landing to the part of Albemarle lying south across the river (now Buckingham Co.) and was busiest when court was in session, also known as Court Days.
- *Court Days* let people visit with their neighbors and visitors who were in town and often became large parties.
  - People often gathered near the courthouse to talk, exchange letters, and enjoy food and drink, including barbecues.
  - There was often entertainment too, including wrestling matches, music, horse races, and greased-pig contests.
- Scott's Landing was incorporated as the town of *Scottsville* in 1818.
